## Notable Events: Previous 24 Hours

The Pentagon committed to sending <u>2,000 ventilators</u> from its military stocks to the Federal Emergency Management Agency (FEMA) and the Department of Health and Human Services (HHS). To date, the Pentagon has not shipped any of these ventilators due to a lack of guidance from FEMA and HHS. Pentagon officials reported 1,000 ventilators are ready to ship immediately once given direction and the remaining 1,000 can be shipped within days of receiving an order.

Michigan now ranks third in the nation for COVID-19-related deaths with 259 total fatalities, behind only New York and New Jersey. The majority of the state's cases are located in the Detroit metropolitan area, with 80% of cases reported in Oakland, Macomb, and Wayne counties.

Texas Governor Greg Abbott on Tuesday told Texans to <u>stay at home</u> for the next month unless they are taking part in essential services and activities, announcing a heightened statewide standard to stem the spread of the new coronavirus. He also announced that schools would remain closed until at least May 4.

Florida Governor Ron DeSantis has issued a <u>mandatory safer-at-home order</u> for the entire state of Florida, starting Thursday at midnight. The order mandates that Floridians stay home and requires "all persons in Florida to limit their movements and personal interactions outside of their home" to essential services or activities for the next 30 days.

Carnival Cruise Line said it will raise approximately \$6 billion in debt and equity while also suspending dividends. The company said these moves, based on assumptions about COVID-19, will provide it with enough liquidity to remain in compliance with its debt covenants for twelve months. Carnival is incorporated offshore, which prevents the company from qualifying for relief under the \$2.2 trillion CARES Act.

Iceland is conducting <u>large-scale COVID-19 testing</u>, having already tested roughly 5% of its population as of 03/31/2020. Biopharma company DeCode Genetics tested 9,000 self-selected individuals and found 1% of tested individuals were positive for the virus. Though only 1% tested positive, 50% of confirmed cases in the study were reportedly asymptomatic. The Directorate of Health cautioned that there may be biases in the data since screening is voluntary.

The U.S. intelligence community concluded China has <u>under-reported</u> both the total number of COVID-19 cases and the number of related fatalities, according to three U.S. officials. The



classified report allegedly concludes China's numbers are fake. Coronavirus task force member Dr. Deborah Birx stated China's data has influenced the world's assumptions about the virus.

The National Institute of Allergy and Infectious Diseases greenlit a <u>drug trial</u> evaluating the effects of Remdesivir on COVID-19 patients. The drug has been previously used to treat Ebola and has known adverse effects that resolved over time, including decreased liver function and gastrointestinal issues.

All England Lawn Tennis Club officials <u>cancelled Wimbledon</u> this year due to the pandemic, marking the first time the event has been cancelled since World War Two. There will be no professional tennis anywhere in the world until at least 07/13/2020.



# **Digital Exploitation**

The Zeus Sphinx banking Trojan recently resurfaced after a three years hiatus as part of a coronavirus-themed <u>phishing</u> campaign, according to BleepingComputer. The malware has been used in the past to harvest financial data via web injections that make use of social engineering in order to convince infected users to hand out authorization codes and credentials.

The Cofense Phishing Defense Center (PDC) has witnessed a surge in COVID-19 phishing campaigns found in environments protected by <u>Proofpoint and Microsoft Office 365 ATP</u>. While these Secure Email Gateways are designed to safeguard end users from clicking on malicious links and attachments, both failed in a new phishing attack, PDC recently observed.

Guardicore Labs reported on 04/01/2020 that they uncovered a sustained malicious campaign dating back to May 2018 that targets Windows machines running MS-SQL servers to deploy backdoors and other kinds of <a href="mailware">malware</a>, including multi-functional remote access tools and cryptominers. According to Hacker News, the attack employs password brute-force to breach Microsoft SQL servers with weak credentials exposed to the Internet.

Computer <u>hackers</u> attacked Italy's social security website, forcing it to shut down on Wednesday, 04/01/2020. The attacks occured as people began applying for COVID-19 benefits, according to Reuters.

LookingGlass analyzed the security flaws previously reported about Zoom teleconferencing software. After looking at 1,689 fully qualified domain names using the Zoom name they found 534 network elements that exhibit behavior that was consistent with a vulnerable or suspicious domain. These domains are being used to steal credentials, install malware, and redirect users to potentially malicious destinations. Likewise, HackerNews reported that Zoom windows users are vulnerable to the 'UNC path injection' vulnerability that could let remote attackers steal login credentials. Related reporting by Business Insider found that trolls are breaking into Alcoholics Anonymous meetings held via Zoom and harassing participants with slurs and mentions of alcohol. Zoom said it was "deeply upset" to learn of the incident and encouraged users to turn on maximum security settings.



# **COVID-19 Email Spam Statistics**

RiskIQ analyzed its spam box feed for the time period of 03/31/2020-04/01/2020. During this period, RiskIQ analyzed 173,164 spam emails containing either "\*corona\*" or "\*covid\*" in the subject line. There were 19,479 unique subject lines observed during the reporting period. The spam emails originated from 10,997 unique sending email domains and 15,489 unique SMTP IP Addresses. Analysts identified 518 emails which sent an executable file for Windows machines.





## **Governmental Guidance**

#### State & Local Governments

#### California

As of 04/01/2020, California has 8,584 confirmed COVID-19 cases and 183 deaths. California Governor Gavin Newsom launched a "Stay Home. Save Lives. Check In" campaign to check on the well-being of California's older residents. Gov. Newsom also announced a new statewide hotline. The hotline will be available to answer questions regarding the crisis in addition to asking for assistance. San Francisco International Airport announced all international flights will be consolidated on one concourse from 04/01/2020 until the end of May.

#### Illinois

As of 04/01/2020, Illinois has 5,998 confirmed cases of COVID-19 and 100 deaths. Illinois Governor JB Pritzker <u>extended Illinois' stay-at-home order</u> to 04/30/2020. The extension announcement included continued suspension of on-site learning. Remote learning is expected to count towards school days.

#### Massachusetts

As of 04/01/2020, Massachusetts has 6,620 confirmed cases of COVID-19 and 89 deaths. Massachusetts Governor Charlie Baker <u>announced</u> Massachusetts' stay-at-home order will extend through 05/04/2020. Worcester officials have begun converting <u>DCU Arena</u> in Worcester into a field hospital. FEMA is expected to deliver medical supplies on 04/01/2020.

#### **New York**

As of 04/01/2020, New York has 76,049 confirmed COVID-19 cases and 1,714 deaths. New York City started building a 350-bed hospital at the <u>Billie Jean King National Tennis Center</u> in Flushing Meadows-Corona Park.

## Washington, DC

As of 04/01/2020, the Washington, D.C. region has a total of 4,061 confirmed COVID-19 cases with 1,249 in Virginia, 1,986 in Maryland, and 507 in the District. D.C. officials <u>announced</u> they would start sending personal protective equipment to healthcare facilities. The Baltimore-based



company Under Armour said it would produce masks, face shields, and fanny packs for The University of Maryland Medical System. George Washington University Hospital reported it would offer drive-through COVID-19 testing for any D.C. resident with a provider referral.
