Notable Events: Previous 24 Hours

Maryland Governor Larry Hogan ordered nonessential businesses closed as of 5:00 p.m. EDT Monday, 03/23/1020, but he did not issue a "shelter-in-place" order, according to NBC reporting. Today's order shuts down all businesses considered non-critical infrastructure sectors as defined by federal guidelines issued last week.

New Jersey Governor Phil Murphy announced today the suspension of all elective surgeries and invasive procedures scheduled to take place after 5:00 p.m. EDT Friday 03/27/2020 until further notice. The executive order applies to all medical and dental operations that can be delayed without undue risk to the current or future health of the patient, as determined by the patient's physician or dentist.

West Virginia Governor Jim Justice issued a stay-at-home order effective Tuesday 03/24/2020 at 8:00p.m., according to West Virginia Metro News. Justice stated that "because bordering states are taking action that may cause folks to make their ways into West Virginia it's a real problem, we can't have that happen." Indiana Governor Eric Holcomb issued a similar stay-at-home order, which goes into effect just before midnight Tuesday and lasts until April 6.

Oregon Governor Kate Brown has issued an order to Oregonians to stay home whenever possible in order to stop the spread of the COVID-19, according to Willamette Week. It is effective immediately, and has no stated end date. People are allowed and even encouraged to leave their home for exercise but must only go for walks, hikes or other exercise if they can stay six feet away from others.

Likewise, <u>Delaware</u>, <u>Louisiana</u>, <u>and Ohio</u> also instituted variations of statewide shelter-in-place orders, as did <u>Indiana</u>, <u>Michigan</u>, and <u>West Virginia</u>. Delaware's order begins at 8:00 A.M. on Tuesday, 03/24/2020, Louisiana's order began at 5:00 P.M. on Monday, 03/23/2020, and Ohio's order begins at 11:59 P.M. on Monday, 03/23/2020. Essential businesses and services will remain open and residents can leave home for essential activities during this time.

Texas Governor Greg Abbott declined to issue a <u>statewide shelter-in-place</u> order, instead welcoming local officials to institute tighter restrictions in their areas. However, <u>Dallas County</u> instituted a shelter-in-place order effective 11:59 P.M. on 03/23/2020 through 04/03/2020. In an effort to increase hospital capacity, Abbott ordered medical professionals to postpone any surgeries that are not medically necessary and suspended regulations to allow hospitals to treat more than one patient in a room.



Facebook CEO Mark Zuckerberg announced the company <u>donated</u> its emergency reserve of 720,000 face masks to medical personnel. He said the company was also working to source more to donate.

Utah Senators Mike Lee and Mitt Romney are both in <u>self-isolation</u> due to their contact with Senator Rand Paul of Kentucky. Romney's doctor ordered the senator into immediate self-quarantine and to avoid voting on the Senate floor.

U.S. Treasury Secretary Steve Mnuchin said <u>lockdowns</u>, which currently affect about one in four Americans, could last ten to twelve weeks. Eighty million Americans are under lockdown, with California, New York, Illinois, Connecticut, and New Jersey instituting statewide policies.

The Trump administration announced it would fund 100% of all <u>National Guard activities</u> in California, New York, and Washington to assist with the COVID-19 response. The administration said the governors would remain in command of their respective National Guard units. FEMA will cover the cost of all missions carried out under this order. At least 7,300 National Guard troops have been activated to respond to the crisis in all fifty states, Washington D.C., and Puerto Rico.

Democrats blocked a \$1.8 trillion stimulus bill during a Senate vote on Sunday, and blocked it again during a vote on Monday. On Sunday, forty-seven senators voted yea while forty-seven voted nay on the bill, which fell short of the necessary sixty votes to pass. Democrats argued the bill was tilted too much in favor of corporations and does not include enough oversight of the \$500 billion in loans and guarantees that could go to approved firms. Republicans, meanwhile, argued the bill contained a number of concessions in favor of Democrats. Negotiations continued in the Capitol as Democrats and Republicans worked to reach an agreement.

Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, said the U.S. is looking closely at reports <u>younger Americans</u> have a much higher rate of hospitalization than expected. CDC data showed approximately 40% of hospitalizations up to 03/16/2020 were between the ages 20 to 54. Fauci highlighted the difference between the Chinese cohort and the European cohort, where the younger populations have a higher rate of severity in cases.

The Wisconsin Supreme Court ordered all <u>in-person court proceedings</u>, including jury trials, to be postponed until 05/22/2020. This order supersedes all existing county-level orders. All state courts will remain open and operational during this time.

The Italian government <u>appealed</u> to U.S. Defense Secretary Mark Esper for U.S. military assistance. Italy requested critical medical equipment, and for troops already stationed in Italy to provide medical personnel and field hospitals in support of Italian troops already responding to the crisis. Related, <u>Esper</u> said U.S. 10 governors requested field hospitals, but added the U.S. military "can't meet everybody's needs" with what it has in its inventory.



President Trump approved California's request for a <u>Major Disaster Declaration</u> on 03/22/2020. The declaration supplements the state's COVID-19 surge planning and provides access to federal funds, which will be made available to state, local, and tribal governments.

Jails in over a dozen states, including California, New York, Ohio, and Texas, are <u>sending home</u> low-level offenders and sick or elderly inmates in response to the pandemic. Other correctional facilities around the country banned visitors, separated inmates, and are screening staff to help prevent the spread of the virus. Officials worry crowded conditions in jails and prisons could facilitate the spread of COVID-19.

The German government plans to introduce new <u>economic stimulus measures</u>, including increasing borrowing by €150 billion in 2020 and passing a €156 billion supplementary budget. The government will likely suspend its debt brake rule, which prohibits the government from presenting structural deficits except during times of <u>crisis or national emergency</u>.

New Zealand will begin a <u>month-long lockdown</u> policy at 11:59 P.M. on Wednesday, 03/25/2020. Residents have a two-day window to prepare for life during the lockdown, which will shutter schools, many businesses, and community services. Businesses and services deemed essential will remain in operation during the lockdown. Trends in case numbers will be evaluated after one month and the lockdown could be partially eased in certain areas based on available data.

The Canadian Olympic and Paralympic Committee announced it <u>will not send athletes</u> to the Tokyo Summer Games if the event is not postponed. Likewise, the Australian Olympic Committee told its Olympians to prepare for the Tokyo Olympic Games in summer of 2021. <u>A veteran International Olympics Committee (IOC)</u> member claimed the IOC will announce soon that the Games will be postponed. IOC President Thomas Bach said he was going to take the next four weeks to decide the fate of the Tokyo Olympics.

Mexico City Mayor Claudia Sheinbaum is temporarily suspending various activities throughout the capital in an effort to reduce the contagion curve and to avoid situations where the city's hospitals could become overwhelmed. The new measures include closing museums, gyms, movie theaters, night clubs, zoos, sports centers and bars until April 20. Schools have already been closed across the country since Friday.



Digital Exploitation

The <u>Department of Justice</u> raised its first federal court action against online fraud relating to COVID-19. According to ThreatPost reporting, the website, "coronavirusmedicalkit.com," offered to give away free vaccine kits that it claimed were manufactured by the World Health Organization. In reality, the cybercriminals first asked buyers to input their payment card information on the website in order to pay a shipping charge of \$4.95. Then, they would steal that credit card and personal information.





COVID-19 Email Spam Statistics

RiskIQ analyzed its spam box feed for the time period of 03/22/2020-03/23/2020. During this period, RiskIQ analyzed 243,881 spam emails containing either "*corona*" or "*covid*" in the subject line. There were 38,698 unique subject lines observed during the reporting period. The spam emails originated from 40,849 unique sending email domains and 22,567 unique SMTP IP Addresses. Analysts identified 237 emails which sent an executable file for Windows machines.





Consumer Landscape

<u>The Federal Reserve</u> announced today a series of new programs to help keep the market functioning. Among the moves is a commitment to keep buying assets under its quantitative easing measures. Other programs include one for Main Street business lending and others aimed at keeping credit flowing. The Fed will move for the first time into corporate bonds, purchasing the investment-grade securities in primary and secondary markets and through exchange-traded funds.

<u>DHL Global Forwarding</u> invoked force majeure, a provision in many service contracts that describes the conditions under which a provider can be relieved of liability for non-performance, based on events that are beyond the provider's control. According to Supply Chain Dive reporting, force majeure does not mean all customers will be affected nor affected equally. It also doesn't mean DHL customers can back out of their contracts despite altered circumstances. A DHL spokesperson told Supply Chain Dive that DHL Global Forwarding continues to provide extensive transport services.


<u>The National Basketball League</u> (NBA) plans to pay players their full salaries due on April 1 but left open the possibility of recouping future salaries for canceled games on April 15, according to a league memo shared with teams Friday.

Some of the world's biggest and best-capitalized companies have joined in the scramble to slash costs, shelve buybacks, or cut dividends and ask banks to extend credit. Companies such as Airbus SE and Royal Dutch Shell PLC are racing for cash amidst the ongoing COVID-19 outbreak.

<u>Palo Alto Network</u> joined with 25 other Bay Area companies to commit an initial \$22 million in collective funding for organizations on the front lines of the COVID-19 crisis. Funds will support the evolving local, regional and global response efforts through several beneficiaries, according to Palo Alto Networks Blog.

Marriott International Inc., the world's largest hotel company, and a growing number of other hotel owners will furlough tens of thousands of workers or slash staff in an effort to steer their companies through the COVID-19 pandemic, according to the Wall Street Journal. Hilton Worldwide Holdings Inc. and Hyatt Hotels Corp. will also furlough employees, the hotel companies said in statements on Sunday, as most travel plans world-wide grind to a halt.

<u>Emirates Airline</u> is suspending all passenger flights from March 25 for a renewable period of two weeks as the UAE halts all inbound, outbound and transit passenger flights. Emirates is the





world's largest A380 operator, and one of the top five largest airlines in terms of passenger and freight ton miles flown. Similarly, <u>Sky Airline</u> announced the temporary suspension of its regular operations in Chile on Monday, according to the company's statement. The suspension will be in effect from March 25 through April 30.

Bed Bath and Beyond announced the closure of approximately 800 stores that do not carry meaningful amounts of essential items like cleaning supplies, health, wellness and personal care products through April 3, 2020. Stores that do carry larger assortments of key items will remain open, with reduced hours, unless local authorities have directed otherwise. Associates will be provided with pay and applicable benefits during this period.







State & Local Governments

California

As of 03/23/2020, California has 1,816 confirmed COVID-19 cases and 35 deaths. President Trump <u>approved</u> the Disaster Declaration for California on Sunday, 03/22/2020, due to the high cases of the novel coronavirus in the state. Governor Newsom <u>criticized</u> young people in the state for ignoring the social distancing requirement by populating the beaches. While Newsom does not want to close beaches and parks, he strongly urged people to help limit the spread of COVID-19 by following the rules in the place.

Illinois

As of 03/23/2020, Illinois has 1,050 confirmed cases of COVID-19 and nine deaths. Mayor Vargas temporarily shut down the Blue Island Police Department after a member tested positive. The Chicago Police Department confirmed a fourth Chicago police officer has tested positive for COVID-19.

Massachusetts

As of 03/23/2020, Massachusetts has 646 confirmed cases of COVID-19 and five deaths. In the last 24 hours, three more people have died in the state of Massachusetts due to COVID-19. The three deaths were men all over the age of 70, one with an underlying health condition. The deaths are reported from Hampden, Berkshire, and Suffolk County.

New York

As of 03/23/2020, New York has 16,916 confirmed COVID-19 cases and 153 deaths. The number of cases in New York increased by 4,601 since yesterday. President Trump announced the approval of the <u>Major Disaster Declaration</u> requested by GovernorCuomo. This declaration brings National Guard troops, medical supplies and around 1,000 medical beds.

Washington, DC

As of 03/23/2020, the Washington, DC-region has a total of 586 confirmed COVID-19 cases: 221 in Virginia, 245 in Maryland, and 120 in the District. D.C. Mayor Bowser announced police and National Guard units will restrict access to the <u>Tidal Basin</u>. The restrictions are to reduce the large crowds that have been gathering to view the cherry blossoms in peak bloom. Mayor Bowser urged residents to view the cherry blossoms virtually to ensure the safety of everyone in the region.




Map of Active School Closures - US


Map of Active Reported Cases - US
