Notable Events: Previous 24 Hours

The Italian 3D printer firm Isinnova teamed up with sports chain Decathlon to produce 3D-printed adapters that <u>convert snorkeling masks into working C-PAP masks</u> for people with severe cases of COVID-19. The invention arrived as deaths and confirmed cases continued to rise in Italy. Isinnova's file for the 3D printing link is free and the company made it available to healthcare facilities which are able to purchase the Decathlon masks and also have access to a 3D printer.

COVID-19 is suspected in the death of a Lancaster, CA teenager. This would be <u>the first</u> <u>virus-related loss of a patient under the age of 18</u>. The teenager died of septic shock; his father was also infected with COVID-19. Public health officials stated Tuesday "early tests indicated a positive result for COVID-19, the case is complex and there may be an alternate explanation" other than COVID-19.

<u>Hospital orders for two old malaria drugs have significantly increased</u> amid discussions the drugs may fight COVID-19. Drugmakers, to include Bayer, plan to donate millions of tablets. Pharmaceutical companies Mylan and Teva also plan to <u>fire up production</u> for hydroxychloroquine. Otherwise, the current short supply may jeopardize patients with lupus and rheumatoid arthritis, where hydroxychloroquine is an approved treatment. Furthermore, Nevada Governor Steve Sisolak signed an <u>order</u> Tuesday requiring proper coding for the drugs' prescriptions. Additionally, <u>vitamin C</u> is currently being used as a treatment in New York hospitals with promising results, and San Francisco based firm <u>Biotechnology announced</u> it would start human testing in three to five months, after it's antibody drugs successfully neutralized COVID-19 in laboratory testing.

Deputy U.S. Attorney General Jeffrey Rosen wrote in a memorandum Tuesday, "Because Coronavirus appears to meet the statutory definition of a 'biological agent'... such acts potentially could implicate the Nation's terrorism-related statutes," according to both <u>Poltico</u> and <u>The Washington Post</u>. Some states have already brought COVID-19-related charges. <u>Missouri</u> police took a man into custody after he posted a video of himself licking Walmart merchandise. In <u>New Jersey</u>, police charged a man after he purposely coughed near a store employee, laughing and telling the employee he was infected. <u>Teenagers in Virginia</u> admitted to police they had coughed near other grocery store customers as a practical joke, after they were reported by store employees. Additionally, <u>Yahoo reported</u> that according to a federal law enforcement intelligence briefing on 02/17/2020, white supremacists were discussing weaponizing COVID-19.



Professional sports have begun issuing stay-at-home orders and announcing company pay cuts. <u>NFL</u> Commissioner Roger Goodell issued a league-wide order Tuesday night prohibiting players and team employees from going to team facilities. The only exceptions are for players receiving medical treatment and for employees providing security. League employees may work remotely to continue business operations and preparations for the 2020 season, to include signing players, evaluating draft prospects, and selling tickets. These orders will last at least until 04/08/2020.

<u>According to the Associated Press, NASCAR</u> president Steve Phellps announced pay cuts to its staff on 03/24/20. NASCAR has suspended its season until 05/09/2020.

Facebook discussed in a <u>memorandum</u> on Tuesday the spike in usage across platforms, in addition to a "weakening" in its ads business in countries that have taken aggressive action to reduce the spread of COVID-19. According to Bloomberg, 98% of the company's revenue comes from advertising. <u>Twitter</u> and <u>Google</u> may also see a revenue loss due to a decrease in advertising.

New research from Comscore shows how <u>in-home data usage has jumped</u> as millions more people work from home and at least 70% of American schools have shut down amid the COVID-19 pandemic. The company found the average in-home data usage is up 18% so far in March 2020 vs. the same amount of time in March 2019. The most notable device-level data usage increases seen in March thus far are for mobile phones, smart speakers, connected TVs and streaming boxes/sticks.

The Senate reached a deal this morning on the \$2-trillion stimulus package. According to <u>CNN</u> the proposal includes "A \$250 billion set aside for direct payments to individuals and families, \$350 billion in small business loans, \$250 billion in unemployment insurance benefits and \$500 billion in loans for distressed companies," and \$130 billion funding for hospitals and \$150 billion for state and local governments. The final text has not been provided and the House vote may take place by 03/26/2020.

New York Governor Andrew Cuomo said New York's current hospital rate is <u>"headed in the right direction."</u> He believed this was due in part to social distancing efforts. However, Gov. Cuomo continued to express the need for ventilators, <u>tweeting</u> "Our single greatest challenge is ventilators. We need 30,000 ventilators. We have 11,000." Gov. Cuomo's tweet occured an hour after President Trump relayed that the emergency hospitals being set up in the Javits Center are ahead of schedule. President Trump <u>tweeted</u> "Many additional ventilators also delivered. Good conversation with Governor Cuomo!" Governor Cuomo also announced plans to continue social distancing efforts by implementing a <u>pilot program</u> that would close streets to automobile traffic.



Prince Charles of Wales and the Duchess of Cornwall are self isolating, after the Prince tested positive for COVID-19. <u>BBC reported</u> that Prince Charles had mild symptoms and the Duchess had tested negative for the virus.

Digital Exploitation

<u>General Electric</u> (GE) disclosed that personally identifiable information of current and former employees, as well as beneficiaries, was exposed in a security incident experienced by one of GE's service providers, according to a BleepingComputer report on 03/23/2020. GE filed the data breach with the Office of the California Attorney General that Canon Business Process Services (Canon), a GE service provider, had one of their employees' email accounts breached by an unauthorized party in February. The email account contained documents of certain GE employees, former employees and beneficiaries entitled to benefits.

As previously reported by Reuters, a hacking group targeted the <u>World Health Organization</u> earlier this month with an apparently unsuccessful spear-phishing campaign designed to harvest credentials as the United Nations organization was grappling with the global COVID-19 pandemic. According to a reporting summary by Bank Info Security, researchers subsequently found that the WHO hackers relied on a long series of sub-domains that sought to take advantage of WHO's Active Directory Federated Service, a single sign-on tool created by Microsoft. Reuters further reported that the advanced persistent threat group suspected of this attack is an organization called DarkHotel, which security researchers assess appears to have ties to South Korea.

More than <u>50 Android apps</u> on the Google Play Store—most of which were designed for kids—have been caught using a new trick to secretly click on ads without the knowledge of smartphone users. According to the Hacker News, the malware in the apps imitate users' actions to click ads from advertising networks such as Google's AdMob, AppLovin', Facebook, and Unity, cybersecurity firm Check Point Research noted in a report shared with The Hacker News.





COVID-19 Email Spam Statistics

RiskIQ analyzed its spam box feed for the time period of 03/24/2020-03/25/2020. During this period, RiskIQ analyzed 181,189 spam emails containing either "*corona*" or "*covid*" in the subject line. There were 17,051 unique subject lines observed during the reporting period. The spam emails originated from 28,661 unique sending email domains and 24,737 unique SMTP IP Addresses. Analysts identified 55 emails which sent an executable file for Windows machines.



Consumer Landscape

<u>Amazon</u> said on Tuesday 03/24/2020 that it will not accept orders for "lower-priority" products in India on a temporary basis; rather, it will prioritize urgent items such as household staples, healthcare, and personal safety products. In a letter to employees on 03/21/2020, <u>Amazon CEO</u> <u>Jeff Bezos</u> said the company had changed logistics, transportation, supply chain, purchasing, and third-party seller processes to prioritize stocking and delivering essential items.

Workers in at least eight <u>Amazon warehouses</u> across the United States tested positive for coronavirus, as the e-commerce giant ramps up hiring to meet surging online sales, according to NPR reporting on 03/24/2020. In recent days, warehouse workers at two separate sites in New York City, in Staten Island and Queens, in addition to employees at warehouses in Jacksonville, Florida., Oklahoma City, Brownstown, Michigan., Katy, Texas., Wallingford, Connecticut. and Shepherdsville, Kentucky., tested positive for COVID-19. <u>Bezos</u> in a letter to employees said he placed purchase orders for millions of face masks to give to Amazon employees and contractors; however, very few of those orders had been filled. Bezos added that masks remain in short supply globally and are at this point being directed by governments to the highest-need facilities like hospitals and clinics.

According to the Atlantic on 03/24/2020, reports have started trickling in of <u>grocery-store</u> <u>workers</u> coming down with COVID-19. A Trader Joe's employee in Seattle tested positive. So did a King Soopers employee in Denver, along with two Fred Meyer employees: one in Monroe, Washington, and one in Portland, Oregon. A worker at the Columbus Circle and Bryant Park Whole Foods locations in New York, through which thousands of people filter every day, tested positive as well. Likewise a <u>Dallas Central Market</u> employee also tested positive for COVID-19. To try to mitigate this threat, workers at various grocery stores have asked for face masks from the federal government. However, the government hasn't been able to procure them, because there's a national shortage and the priority remains health-care workers.

<u>Retailers</u> are suspending and canceling clothing orders, threatening millions of factory jobs in Asia just as China shows signs of recovering from the worst of the coronavirus outbreak. According to the Wall Street Journal, among the first to be hit by the consumer shutdown in the West are suppliers to the world's "fast-fashion" giants, like H&M.

<u>JPMorgan Chase & Co.</u> on 03/23/2020 issued a hiring freeze across most of the firm as millions of people stay at home to help stem the spread of the coronavirus, according to Bloomberg reporting. Likewise, as COVID-19 deaths have increased in <u>Ohio</u>, Governor Mike DeWine implemented a hiring freeze for the State Government on 03/23/2020.



<u>Texas Governor Greg Abbott</u> on 03/24/2020 directed the Texas Department of State Health Services (DSHS) to issue guidance allowing restaurants to sell bulk retail products from restaurant supply chain distributors directly to consumers provided that such foods are in their original condition, packaging, or presented as received by the restaurant. Under this guidance, restaurants will be able to sell items like packaged meat, fruit and vegetables, and dry goods directly to the public to prepare and consume at home.

On Tuesday 03/24/2020, <u>Washington D.C. Mayor Muriel Bowser</u> ordered closed all non-essential businesses in the District. Maryland Governor Larry Hogan announced similar measures on 03/23/2020. According to the Washingtonian, neither he nor Bowser currently plan to issue any shelter-in-place orders. Relatedly, the <u>Washington D.C. Metro</u> will close 17 more stations on Thursday 3/26/2020 in an effort to preserve cleaning supplies and protect its employees amid COVID-19 pandemic. Likewise, <u>New York</u> is cutting subway, bus and commuter rail service as ridership has plummeted and some workers have tested positive,.

<u>Netflix</u> is reportedly experiencing outages, according to the Independent. On 03/25/2020, tracking website Down Detector showed problems across the world, though they were largely focused in Europe. The outage came at around 6:00 p.m. on the continent, likely meaning that many people had just finished work and were attempting to access the website.

As of 03/25/2020, California has 2,634 confirmed COVID-19 cases and 54 deaths. San Francisco officials <u>closed</u> City Hall to the public Wednesday morning amid the growing coronavirus pandemic. Some essential services, including the treasurer's and clerk's offices will continue, but the public will not be admitted inside until at least April 7.

Illinois

As of 03/25/2020, Illinois has 1,537 confirmed cases of COVID-19 and 16 deaths. Illinois Senate Republicans <u>sent a letter</u> Wednesday to Governor J.B. Pritzker requesting the state's income tax filing deadline be extended from April 15 to the new federal deadline, July 15. Gov. Pritzker said during a news briefing Sunday that his administration was evaluating whether the state income tax filing deadline could be extended, possibly with the help of federal borrowing or federal aid.

Massachusetts

As of 03/25/2020, Massachusetts has 1,159 confirmed cases of COVID-19 and 11 deaths. Boston Mayor Martin Walsh issued a <u>temporary executive order</u> allowing essential businesses in Boston to use plastic bags. The order also exempts requirements that businesses charge customers fees for bags. The exemption only applies to essential businesses listed in Gov. Baker's March 23 order that went into effect Tuesday.

New York

As of 03/25/2020, New York has 26,395 confirmed COVID-19 cases and 277 deaths. New York City makes up more than half of the state wide cases of COVID-19 with 15,597. Senior medical students at NYU were <u>offered</u> a chance to graduate three months early, if they agreed to immediately go to work at NYU Langone Health's Internal Medicine and Emergency Medicine departments. The offer was made in an attempt to help relieve the overworked and short-staffed medical professionals at NYU Langone.

Washington, DC

As of 03/25/2020, the Washington, D.C.-region has a total of confirmed COVID-19 cases: 291 in Virginia, 424 in Maryland, and 187 in the District. D.C. Mayor Muriel Bowser <u>ordered</u> nonessential businesses to close starting 10:00 p.m. Thursday. Mayor Bowser said it's possible the city will join Virginia in closing schools for the rest of the academic year.




Map of Active School Closures - US
