### Noteable Events in the Past 24 Hours

California Governor Gavin Newsom <u>announced</u> the closure of all beaches and state parks effective 05/01/2020. The announcement comes after media coverage showed crowded conditions at the state's beaches, in violation of the stay-at-home order.

According to the Department of Labor, there were <u>3.839 million new unemployment claims</u> for the week ending 04/25/2020. There are 30.307 million unemployment claims filed since 03/30/2020, which represents 18.6% of the working-age population.

The Office of the Director of National Intelligence (ODNI) issued a statement saying it had concluded COVID-19 was neither man-made nor genetically modified. The ODNI said it is continuing to answer whether the virus came from a laboratory or an animal market in Wuhan, China.

Food plant workers are <u>clashing with employers</u> over safety concerns at work. Union officials and worker advocates are pushing for unpaid sick leave and other accommodations, but companies are resisting the demands. In some cases, companies have allegedly threatened to fire workers who took leave while feeling ill. The Mission Foods plant in Mountain Top, PA reported 109 employees out of 500 tested positive for the virus, but one worker alleged that he would be fired if he took sick leave. The company, in turn, responded that it has not terminated any employee who has taken approved leave.

U.S. workers on unemployment <u>receive an average of \$978 a week</u> from state and federal government payments, compared to approximately \$378 a week last year. Approximately half of the individuals receiving unemployment benefits are now making more than when they were working.

According to data provided by the Bureau of Prisons, over <u>70% of inmates</u> tested in federal prisons have COVID-19. As of 04/29/2020, 31 inmates at federal correctional facilities have died from the virus. Officials have taken steps to curtail the spread of the virus, including limiting inmate movement, setting up tents to increase bed space, isolating inmates, and identifying others for possible home confinement.

NFL commissioner Roger Goodell <u>announced</u> the NFL will cut pay for some employees and will furlough others. The pay cuts will range between 5% and 15%, with higher-ranking employees seeing the largest cuts. Goodell will cut his own salary from \$40 million a year to no pay at all.

<u>The Prime Minister of the United Kingdom</u>, Boris Johnson suggested British people will be encouraged to wear face masks when the UK's lockdown is slowly eased, in a major shift from



the government's previous advice. Boris also said that the UK is "past the peak" of its COVID-19 outbreak.

Florence's Peretola airport and Rome's Ciampino airport will fully reopen May 4, according to the <u>Italian Transport Minister</u>. Italian Prime Minister, Giuseppe Conte said the country will slowly relax lockdown measures based on how the contagion spreads in different regions. Conte's comments come as 13 out of the 20 Italian regions have asked the government to reopen certain activities.



### **Digital Exploitation**

Cyber insurance professionals are warning that the COVID-19 pandemic may complicate potential insurance payouts related to cyber attacks, according to LookingGlass reporting. Many cyber insurance policies exclude network-attached devices owned by employees from coverage, meaning a ransomware attack that encrypts employer data on an employee-owned device may fall outside of coverage.

Researchers at Kaspersky Labs have observed since March that cybercriminals have shifted to targeting networks with remote desktop protocol (RDP) brute-force attacks. Cybercriminals utilize the compromised account credentials along with automated tools to access these networks. Once gaining access, cybercriminals may steal data, drop malware, or target the network via ransomware, according to LookingGlass reporting.

A new <u>phishing</u> campaign is targeting outsourced human resource contractors, according to Help Net Security. The phishing email is sent to employees from an alleged HR contractor informing them that additional stimulus money is being provided to them and asking them to view the latest payroll which leads to a malware download.

The <u>infostealer</u> EventBot, has targeted Android mobile users of more than 200 different banking, money-transfer services and general cryptocurrency wallet apps. EventBot was first identified in March 2020 but researchers warn that it's rapidly evolving with new versions being released every few days, according to ThreatPost reporting.



### **COVID-19 Email Spam Statistics**


RiskIQ analyzed its spam box feed for the time period of 04/29/2020-04/30/2020. During this period, RiskIQ analyzed 81,958 spam emails containing either "\*corona\*" or "\*covid\*" in the subject line. There were 16,984 unique subject lines observed during the reporting period. The spam emails originated from 12,534 unique sending email domains and 11,216 unique SMTP IP Addresses. Analysts identified 106 emails which sent an executable file for Windows machines.





### **Governmental Guidance**

### State & Local Governments

#### California

As of 04/30/2020, California has 48,829 confirmed cases of COVID-19 and 1,956 fatalities. California Governor Gavin Newsom <u>announced</u> Wednesday a three-part plan to distribute food to Californians in need. The state created a partnership with 128 farmers and ranchers to distribute fresh produce, dairy, and meat to food banks around the state. Newsom said the goal is to distribute 21 million pounds of fresh food on a monthly basis. He said the "food boxes" would contain three to four days worth of food for a family of four.

#### Illinois

As of 04/30/2020, Illinois has 50,358 confirmed cases of COVID-19 and 2,215 fatalities. The Department of Business Affairs and Consumer Protection (BACP) will host a <u>webinar</u> Thursday to help businesses navigate Governor Pritzker's new stay-at-home order. Effective Friday, 05/01/2020, the stay-at-home order will provide increased flexibility for certain businesses along with important new guidelines to protect workers and consumers. BACP is also providing twice-daily webinars to provide information on the new Chicago Microbusiness Recovery Grant Program.

#### New York

As of 04/30/2020, New York has 299,691 confirmed cases of COVID-19 and 23,477 fatalities. Rockland County officials <u>announced</u> the re-opening of county parks effective 6:00 AM, Friday, 05/01/2020, with the exception of H. Pierson Mapes Flat Rock Park in Hillburn. Parks will be open for walking only. Features such as dog runs, playgrounds, restrooms, fishing areas, and picnic areas will remain closed for the foreseeable future. H. Pierson Mapes Flat Rock Park in Hillburn Hillburn – which has no walking paths – will remain closed.



#### Texas

As of 04/30/2020, Texas has 27,390 confirmed cases of COVID-19 and 759 fatalities. The Texas General Land Office <u>ordered</u> all of the state's public beaches to reopen, effective 12:00AM 05/01/2020, as part of the governor's phased reopening of the state's economy.

### Washington, DC

As of 04/30/2020, the Washington, D.C. region has a total of 39,917 confirmed cases of COVID-19, with 20,849 in Maryland, 14,962 in Virginia, and 4,106 in the District of Columbia. Maryland has 1,078 fatalities, Virginia has 522 fatalities, and the District of Columbia has 205 fatalities. Virginians will be able to <u>resume</u> non-emergency visits to the doctor, dentist or veterinarian later this week after Governor Ralph Northam announced the state's first rollback of restrictions since the coronavirus crisis began escalating in March.
